Yuhua Trust Scheme

Objective

- To assist needy children in Yuhua Division to defray the cost of education, which include transport, uniform and stationery/textbook.

Eligibility

- Applicants should fulfil all the following conditions:
 - a. Living in Yuhua as shown on their identity card,
 - b. Currently studying in Primary School, Secondary School, Junior College, Pre-University Centre, Institute of Technical Education and Polytechnics in Singapore,
 - c. Will continue to study in the institutions as stated in (b) in the following year, and
 - d. Household income not exceeding \$2,000 or per capita household income not exceeding \$500¹.
 - e. Has performed well in school, eg good attendance and conduct in school.

Supporting Documents Required

It is important to submit the following supporting documents together with the application. Failure to furnish copies of the supporting documents will result in delay in assessment of application.

1. NRIC / Birth Certificate (of applicant)
2. Latest school result slip (of applicant)
3. Latest pay slip, CPF statement or Income Tax returns (of all working adults in household)

Application/Disbursement Procedure

1. Application forms are available for collection at Yuhua Community Club or can be downloaded from Yuhua website (www.yuhua.org.sg).
2. All information required in the application form is to be provided. The completed form must be endorsed by the school of the applicant and submitted with supporting documents to Yuhua Community Club (90 Boon Lay Way Singapore 609958).
3. Applicants will be notified by post of the success of their applications.
4. The award will be in the form of cash and vouchers as decided by the Yuhua CCC Welfare and Education Sub-committee. There is only one payout per approved application per calendar year.

Approval of Awards

1. The Yuhua CCC Welfare and Education Sub-committee will decide on the maximum number of awards for each category of applications and may vary the amount of each award according to the response.
2. The decision of the Yuhua CCC Welfare and Education Sub-committee on the granting of awards shall be final.

¹ In the calculation of household income, the income of all the members in the household who are employed or in business, including those on National Service, are to be included.
